Payment Methods:

Payment is accepted by bank transfer, child tax credits and voucher schemes, cash or cheque. All sessions must be paid for before attendance.

Confirmation of place

Your place will only be confirmed on full payment. An acknowledgment will be sent with payment details however booking confirmation will only be sent when payment is received

Refunds/cancellation of classes

Foresteers has the right to cancel sessions without refund in exceptional circumstances (eg. extreme weather, sickness). Should a session be cancelled, you will be notified as soon as possible via our Facebook page, by email, by mobile text or by phone.

A catch-up session will be offered at an alternative time.

Holidays and sickness policy:

Regrettably we cannot offer discounts or refunds to cover your booked holidays due to the need to ensure continuity of service.

Illness

Parents are asked to keep their child at home if they have a serious infection and to inform the setting as to the nature of the infection so that other parents can be alerted.

Please keep your child at home if he/she:

- Has a fever or has had one in the previous 24 hours
- Has had an upset stomach or diarrhoea in the previous 48 hours
- Has heavy nasal discharge
- Has discharging eyes

Has symptoms of a possible communicable diseases such as:

- Measles
- Chicken pox
- German measles
- Whooping cough
- Impetigo
- Scarlet fever
- Hand, foot and mouth disease
- Norovirus
 - Covid symptoms or a positive test

We cannot offer a refund for a lesson missed due to illness.
